### **Research Fund Report**

The market value of the Research Fund as of 4/8/2002 was \$7,899,302. The AOS accounting firm, Hoffmann & Hoffmann, recommended funding between \$300,000 and \$350,000 for the approved grants for 2002-2003. Of this amount \$80,000 was earmarked for the Clinician-Scientist Award.

Seven research grants and two Clinician-Scientist awards were received and reviewed by the Research Fund Trustees. The total cost of the requests was \$438,047. Due to the quality of the grants, only three research grants were funded and one Clinician-Scientist award was funded for a total cost of \$199,891.

#### **Clinician-Scientist Award**

Dr. Charles Della Santina from Johns Hopkins University School of Medicine received the Clinician-Scientist Award for his research entitled, "Electrical Stimulation for Restoration of Vestibular Function."

#### **AOS Bylaws**

At the Annual Business Meeting, May 11, 2002, the proposed AOS bylaws revisions and the new AOS Research Foundation by-laws were unanimously approved by the members present. AOS will become the controlling tax-exempt corporation while the research fund will become a fully owned tax-exempt subsidiary of AOS. This will change the AOS federal income tax status from a private foundation to a public charity.
