139th ANNUAL SPRING MEETING

From the AOS President, Dr. John K. Niparko

Dear AOS Colleague:

Hope your new year is off to a great start. I wanted to bring you up to date on a couple of AOS initiatives that have come to the fore over the past few months.

First, as you are probably aware, three years of hearings and committee meetings of Council members with representatives of the Centers for Medical Services yielded important changes in the criteria for cochlear implant coverage and a policy change that now grants coverage for procedures that provide bone conduction via semi-implantable, osseointegrated implants. While both policy changes ostensibly affect Medicare coverage, we are well aware that such national coverage decisions can affect commercial carrier decisions.

In the summer of 2005, Dr. David Nielsen as Executive Vice-President of our Academy was contacted by the leadership of the American Academy of Audiology to discuss the potential for greater collaboration. The proposal potentially represents a refreshingly new level of interaction between the AOS, the ANS, the AAO-HNS, and the AAA. Several concerns from past interactions have now been addressed. On the horizon are initiatives related to the training, certification, and oversight of audiologic technicians and scope of audiologic practice legislation. Looming large, as well, are proposals of major reforms and potential cuts for audiologic procedures.

A truly collaborative approach can provide synergies that could prove powerful in addressing the challenges we share with audiologists. Council is hopeful that a consistent model of collaboration can be developed in forging a new partnership with our audiologic colleagues.

At our midwinter meeting, the Council also reviewed the investment management of our research and educational funds. We were quite satisfied with the performance of our investments, and we were able to negotiate further reductions in management fees, thus realizing an extremely low fee structure when compared to peer investment options.

With spring around the corner, I do look forward to us getting together for the annual AOS meeting, May 20 and 21, at the Hyatt Regency Hotel in Chicago, IL. The Council approved an exceptionally diverse educational program. Several highly innovative reports of new otologic procedures will be heard. We have also planned an audience response session on stapes surgery, an update on new diagnostic capabilities through CT and MR imaging, and an intriguing scientific session on how we hear, and how we listen. Do plan to take notes on the latter topic to share with your spouse or significant other.

Please note as well, that one of the grand traditions of the AOS—the annual banquet and award of merit ceremony—will be held on Sunday evening, May 21, 6:30 pm in the Regency Ballroom A. Please plan on attending and supporting this important event where we will introduce the new members of the AOS, and marvel at the dance talent that exists within the AOS.

Banquet tickets may be purchased through the COSM registration. Cost of the Banquet is \$125.00 per person for members and invited guests only.

I look forward to seeing you in Chicago.
